3. Proof of Identification (State ID, Driver License, Original SS Card and Birth Certificate)
4. Willing to undergo a Credit & Criminal Background Check (no cost to applicant) previous history of evictions and large unexplained credit balances maybe reasons for rejection. Violent & Sexual criminal histories may also reasons for rejection.
5. Capacity to live independently, (with or without care assistance)
